**Puppy Deposit Agreement**

Deposits are accepted in order to give individuals the opportunity to reserve a puppy that is currently available.

Whenever a litter is born, individuals on our Reservation List that have previously made a \$200 deposit are given the first chance to pick a puppy from the litter.

Puppy selections will be in the order that deposits have been received.

JHW Ranch reserves the right to select the first choice of puppy from any litter to hold back for the furthering of our breeding program.

After all individuals on our Reservation List have made their decisions to select a puppy from a current litter, we then begin accepting Full Deposits on the remaining available puppies in the litter.

Full Puppy Deposits are \$500. This Full Deposit will be applied towards the total purchase price of the puppy and the balance will be due at the time of pickup/delivery.

Deposits are NON-REFUNDABLE and will not be returned if you change your mind.

Any fees associated with your deposit transaction will be added to the cost of your puppy.

Deposits CAN BE TRANSFERRED to a subsequent litter, however the deposit will become void after a time period of one year and will remain non-refundable.

Should something happen to the reserved puppy, another puppy from the current litter (if available) or a future litter will be offered, and the deposit will transfer to that puppy, or, if requested, a refund will be given.
