Puppy Reservation List Agreement**

**Advance deposits of \$200** are accepted in order to provide individuals the opportunity to be placed on a Reservation List for future litters.

Whenever a litter is born, individuals on the Reservation List are given an opportunity to decide if they are interested in an available puppy or to pass and wait for a future litter.

Available puppies will be offered to individuals on the Reservation List in the order the **Advance Deposits** are received.

Individuals on the Reservation List are allowed to “pass” on a puppy that meets their gender and/or color criteria a maximum of three times. After that, the **Advance Deposit** will be lost as well as the locked in price and place on the list. To regain placement on the list, another deposit would have to be made.

If the litter should not offer the gender and/or color of puppy desired, you will remain on the Reservation List in the order your deposit was received relative to others on the list and be able to select an available puppy from a future litter.

In the event that JHW Ranch Goldens does not produce a puppy that meets your criteria of gender and/or color within one calendar year of when the **Advance Deposit** was made, a full refund of said deposit will be offered. Buyer may then choose to accept the refund or remain on the list until their desired puppy is born.

JHW Ranch Goldens reserves the right to select the first choice of a puppy from any litter to hold back for the furthering of our breeding program.

After puppies are born, when Buyer has indicated their interest in selecting an available puppy from a litter, the **Full Deposit** balance of \$300 (for a total of \$500) is due **before puppies are 6 weeks of age**. The **Full Deposit** of \$500 is required to secure your selection spot when puppies are chosen at 8 weeks of age.

The **Full Deposit** (\$500) will be applied towards the total purchase price of the puppy. The balance of the final cost of the puppy will be due at the time of puppy selection/pickup.

Both **Advance Deposits** and **Full Deposits** are **NON-REFUNDABLE** and will not be returned if you change your mind.

Any fees associated with your deposit transactions will be added to the cost of your puppy.
